GENERAL OVERVIEW

The Budget for the financial year 2015 had certain peculiarities as a transitional would be prepared, submitted and partially implemented by the out-going administration and completed by the incumbent. The Government in the year under review faced a lot of constraints and other fiscal and monetary challenges and shortfalls as expected revenues were not realizable as projected in the budget.

CONSOLIDATED REVENUE FUND

The Budgeted Revenue from all sources both the statutory (*that is from the Federation*) and Internally Generated were put at ₦48,572,000,000.00 (Forty-eight billion, five hundred and seventy-two million naira) for the former and ₦8,048,000,000.00 (Eight billion, forty-eight million naira) for the latter.

STATUTORY ALLOCATION

The federally Collectible Revenue inclusive of the Statutory Allocation, Value Added Tax and other receipts from the Federation stood at ₦43,743,596,012.08 (Forty-three billion, seven hundred and forty-three million, five hundred and ninety-six thousand, twelve naira and eight kobo) were realizations in the period under consideration and represents almost 90% of the estimated of ₦48,572,000,000.00 (Forty-eight billion, five hundred and seventy-two million naira).

The other revenue were the Capital Grants, Contributions and reimbursement received of ₦10,755,445,727.68 (Ten billion, seven hundred and fifty-five million, four hundred and forty-five thousand, seven hundred and twenty-seven naira and eight kobo) out of the estimated of ₦14,640,000,000.00 (Fourteen billion, six hundred and forty million naira), the other capital receipt of ₦1,307,587,295.55 (One billion, three hundred and seven million, five hundred and eighty-seven thousand, two hundred and ninety-five naira fifty-five kobo) of the estimated ₦9,310,000,000.00 (Nine Billion, three hundred and ten million naira) and the intervention extended as a bail out of ₦10,000,000,000.00 (Ten billion naira) a concessionary loan agreement guaranteed by the Central Bank of Nigeria with ECA as a collateral. The Micro, Small and Medium Enterprises loan scheme of ₦2,000,000,000.00 was also accessed by the state with a change of purpose to finance development projects.

1.1.2 INTERNALLY GENERATED REVENUE

The Internally Generated Revenue performance was satisfactory and recorded a collection of ₦8,833,545,124.77 (Eight billion, eight hundred and thirty-three million, five hundred and forty-five thousand, one hundred and twenty-four naira seventy-seven kobo) an increase compared to that of the previous year of ₦6,348,989,377.21 (Six billion, three hundred and forty-eight million, nine hundred and eighty-nine thousand, three hundred and seventy-seven naira twenty-one kobo). The expected revenue for the year was ₦5,553,280,000.00 (Five billion, five hundred and fifty-three million, two hundred and eighty thousand) with a surplus collection of ₦3,280,265,124.77 (Three billion, two hundred and eighty million, two hundred and sixty-five thousand, one hundred and twenty-four naira seventy-seven kobo) observed at the end of the financial year.

The performance was encouraging on the various codes of collection and recorded 159% (that is 59% above the budgeted figure)

2.1 EXPENDITURE

2.1.1 THE RECURRENT EXPENDITURE

The recurrent expenditure inclusive of the personnel cost, the overhead cost and the Consolidated Revenue Fund Charges represent 58% of total expenditure budget provision for the financial year 2015 and amounted to ₦58,858,000,000.00 (Fifty-eight billion, eight hundred and fifty-eight million, three hundred thousand naira only). While the actual utilized for operational commitments were to the tune of ₦54,614,434,778.18 (fifty-

four billion, six hundred and fourteen million, four hundred and thirty-four thousand, seven hundred and seventy-eight naira, Eighteen kobo) with a savings of ₦4,220,210,221.82 (Four billion, two hundred and twenty million, two hundred and ten thousand, two hundred and twenty-one naira eight-two kobo).

The comparative analysis between the budgeted and the actual in terms of budget implementation performance was 92.83% despite the shortfalls on the revenue receipts in the year due to the dwindling oil revenue which constitutes more than 83.7% of the Government inflows.

2.1.2 PERSONNEL COST

The Personnel Cost actual expenditure profile of ₦35,616,766,415.20(Thirty Five Billion, Six Hundred and Sixteen Million Seven Sixty Six Thousand, Four Hundred and Sixteen Naira, Twenty Kobo) was observed to be the expended amount for the settlement of salary bills of the Government in the period under consideration.

The amount was inclusive of ₦13,986,551,876.42(Thirteen Billion, Nine Hundred and Eighty Six Million ,Five Hundred and Fifty One Thousand, Eight Hundred and Seventy Six Naira ,Forty two Kobo) for Local Education staff with ₦21,630,074,361.00(Twenty one Billion ,Six Hundred and thirty million ,seventy four thousand ,three hundred and sixty one naira) being the state's salaries of Government employees.

The budgetary provision was ₦36,234,985,000.00(thirty six billion ,two hundred and thirty four million ,nine hundred and eighty five thousand naira) compared with the actual of ₦35,616,766,415.20(thirty five billion ,six hundred and sixteen million ,seven hundred and sixty six thousand ,four hundred and fifteen naira, twenty kobo) reflects a utilization of 98% of the provision with a favorable balance of ₦618,218,584.80(six hundred and eighteen million ,two hundred and eighteen thousand, five hundred and eighty four naira ,eighty kobo).

2.1.3 OVERHEAD COST

The budgeted amount of the overhead cost was ₦17,586,041,000.00(Seventeen billion, Five Hundred and Eighty six million ,Forty One Thousand) and the expenditure recorded stood at ₦14,806,051,988.11(Fourteen billion ,Eight hundred and six million, fifty one thousand ,nine hundred and eighty eight ,eleven kobo) respectively. The utilized performance was 84.19% translated to ₦2,779,989,011.90(two billion ,seven hundred and seventy nine million ,nine hundred and eighty nine thousand, eleven naira, ninety kobo) savings.

2.1.4 CONSOLIDATED REVENUE FUND CHARGES

The Consolidated Revenue Fund Charges provides for the settlement of Pensions, Debt Services, Remuneration of Political and Public office holders and expenditure of the Judiciary.

The budgeted was #4,101,930,000.00 and the actual expenditure amounted to N3,172,524,254.00 with a savings of N929,405,746.00.

The audit observed and wishes to emphasize the non-inclusion of the salaries of the Governor and the Deputy Governor as a Consolidated Revenue Fund Charges in conformity with Section 124(4) of the Constitution of the Federal Republic of Nigeria 1999 (as amended).

3.1 CASH FLOW STATEMENT

The Cash Flow reflects the inflow matched with the outflows and reports cash flow of the organization and further classified as Operating Activities, Investing Activities, Financial Activities and reconciles the balances of Cash and its equivalent as at the end of the financial year.

The previous year (2014) balances should be adjusted to reflect the accurate brought forwards by the Accountant General and comment on the aspect thereon and attach an addendum with explanatory note.

4.1.1 ASSETS AND LIABILITIES STATEMENT

The Board of Survey report as observed and emphasized in our previous reports does not reflect the actual balances of the Ministries, Departments and Agencies as at the end of the financial year. An improvement can be achieved with the balances produced from the IFMIS and accuracy of the figures ensured, extracted and presented as a more sound and defensible data.

4.1.2 CASH AND BANK

The aggregated cash and Bank balances stood at ₦14,990,080,351.00 as reflected in the assets and liabilities. The cash balance was ₦1,861,100,991.11 and the bank balances amounted to ₦13,128,943,357.10.

4.1.3 INVESTMENT

The Investment in quoted and unquoted companies reflects a down turn of value of the stocks. The previous year recorded a total value of the investment of ₦1,438,641,614.91 to the current years ₦1,265,272,645.00.

The audit observed that no dividend was declared (even the one reflected in the cashflow statement was not supported) from the quoted shares acknowledged by the Ministry of Finance.

The audit noticed lodgment of funds on short term deposits by the ministry of finance of which no analysis was tendered for audit tracking. An elaborate transparent and accountable analysis of this short term investment to be put in place for easy tracking of public funds on trust.

EXTERNAL LOAN

The position of the external loan as presented indicated a balance of ₦6,413,834,977.96 an increase observed from the previous years balance of ₦5,566,010,769.90 and the provision in the budget was ₦2,100,000,000.00.

The treasury to ensure reconciliation with the Federal Debt Management office at regular basis to establish the true view of the debts profile of the state.

INTERNAL LOAN

The internal loans stood at ₦11,916,666,666.70 as per the Debt Management submission. The detailed analysis should be provided to support the astronomical up surge noticed from the reflected figure of ₦1,569,942,056.74 in the 2014 financial year. The Accountant General to up date and reconcile the debt profile.

LOANS TO CORPORATION

The report submitted by the Accountant General showed that no loan was extended to a corporate entities owned by the Government in the year under review.

The loan reported in our previous reports should be reviewed as recommended in the previous reports of the Auditor General presented to the House of Assembly.

5.1.1 CONSOLIDATED REVENUE FUND STATEMENT

The overall Internally Generated Revenue performance was 141.06%, the projected being N5,553,280,000 (not inclusive of; N2,494,720,000.00 a Recurrent Grants to MLG, LGSC and LGAuG) and the actual a total of N7,833,545,124.80 and the statutory allocation recorded a 90.06% collection of revenue with a shortfall of 9.94% which translates to N4,828,403,988.00 and N43,743,596,022.08 as the actual collectible from the Federation Account against the projected of N48,572,000,000.

The other revenue sources to finance the expenditure in the Consolidated Revenue Fund are the Primary School Financing Funds of N14,082,350,459.85 and Local Government 60% Gunduma Staff Cost of N1,557,803,879.30.

The expenditure on the other hand amounted to N54,585,664,768.23 broken into Recurrent Expenditure (Personnel Cost and Overhead Cost), Consolidated Revenue Fund Charges and Miscellaneous Expenditure.

6.1.1 CAPITAL DEVELOPMENT FUND STATEMENT

The Capital Development Fund the custodian or repository of Capital Expenditure Funds consists of receipts and the expenditure on the Capital Development Projects and Programmes.

The total Capital Receipts stood at N35,389,237,425.41 and the Capital Expenditure for the year was N27,368,597,441.34 divided into four (4) sectors : Economic Development Programmes, Social Development Programmes, Regional Development Programmes and the General Administrative Services and Programmes.

STATE WIDE REPORT

PURCHASE OF NEW VEHICLES

- 1) No report of purchase of new Government vehicle was received from any MDA. However, the MDAs were made aware of the importance of keeping a fixed assets register hence, the inclusion of all vehicles acquired into the register for identification emphasized.
- 2) REPORT OF ACCIDENTAL VEHICLES
Government agencies are too reluctant in reporting cases of accidental Government vehicles. The office(oaug) liaise with our Resident Auditors and authorized them to keep track on newly purchased vehicles and report same to the headquarters.
- 3) LOSS OF FUNDS, STORES AND THEFT OF GOVERNMENT PROPERTIES
In the year 2015 only Ministry of Commerce reported the issue of theft of its motorcycle which was stolen at a parking lot in the new secretariat complex. The other MDA's either ignored to report theft cases or didn't occur in their organizations. There was also no report on fire incidence and loss of funds/stores.

4) PENSION AND GRATUITY

A total of 1,110 files were treated and returned the directorate of salary and pension for the period of January-December, 2015. While, the sum of N84,252,529.74 were endorsed and recovered as amount due to the Government. A summary of the details in the annexure attached.

5) AUCTION OF GONVERNMENT PROPERTIES

The board of survey in office of the Head of civil service inspected and priced items slated to be auctioned which were referred to the Auditor General for comment and observation. The vetted auction price of the vehicles and assorted items disposed amounted to N1,610,000.00. The itemized items captured in annexure-B.

CONCLUSION

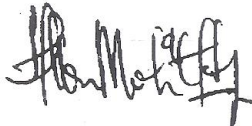
The Annual Accounts submitted was subjected to statutory confirmations and the review satisfactorily carried out.
